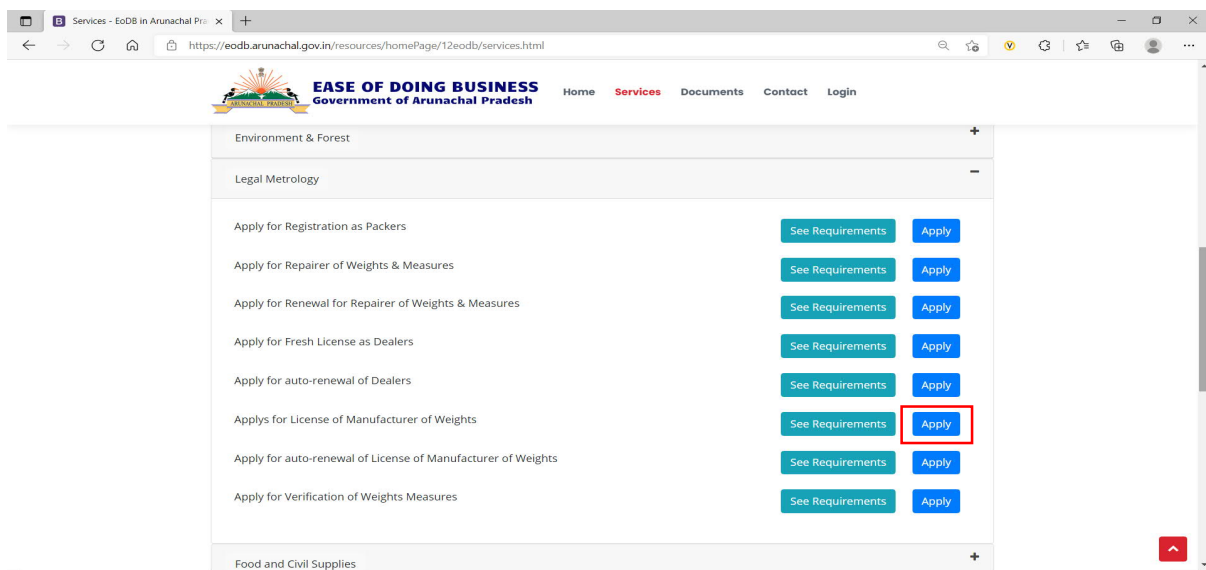

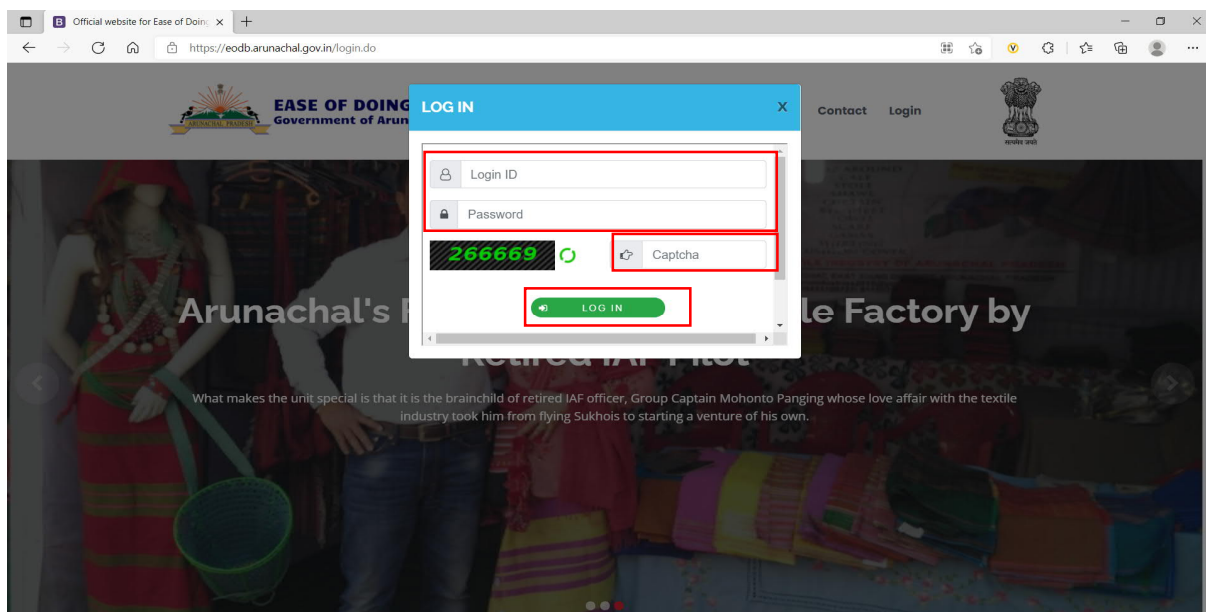
Step 2: Navigate to the EODB Link and Click on "Login"
